(the "***Company***"), with the head office in Bacău, 9<sup>th</sup> Condorilor Street, registered with the National Trade Register Office under number J04/1137/1991 and having sole registration number 950531, convened and conducted in accordance with statutory provisions on the date of December 16<sup>th</sup>, 2021, where 87,9027% of the share capital was present or represented, that is 133.855.962 shares of the total of 152.277.450 shares,**
